

DECLARATION OF COMPLIANCE FOR FOOD CONTACT MATERIALS

We herby declare that the products manufactured in our company:

Meet the relevant requirements laid down in the Regulation (EC) No. 10/2011 on plastic materials and articles intended to come into contact with food and in articles 3, 11(5), 15 and 17 of the Regulation (EC) No 1935/2004 on materials and articles intended to come into contact with food.

On the pre-condition that the product is used according its specification global and specific migration shall meet the legal requirements.

Migration tests have been performed according the Regulation (EC) No. 10/2011 and the LFGB (Lebensmittel-, Bedarfsgegenstände- und Futtermittelgesetzbuch) by Intertek Consumer Goods GmbH, Würzburger Str. 152, 90766 Fürth / Deutschland; Test Report No. FUFDC 1211437R under the following conditions:

Further tests have been performed on specific migration of formaldehyde, primary aromatic amines, specific migration of fluoride, migration of metals, screening of organic phenolic compounds and sensory testing with positive results.

According to the suppliers' confirmations the raw materials comply with the regulation (EC) No. 10/2011
